Production (defrosting, cutting, cooking, mixing, sterilization) and packaging of meat products (canned meat products produced from pork, beef, chicken and turkey meat; frozen shaped meat products produced from pork and beef meat; sausage (fermentation, smoking, pasteurization) products and cured (salting, smoking) meat products produced from pork, beef, chicken and turkey meat) packed in Al / Fe cans, plastic foil / plastic foil sealed bags in MAP or vacuum packaging. Cutting, processing and packaging of fresh and frozen pork and beef meat packed in plastic foil sealed bags packaging. Production of plant based frozen shaped product. Production (mixing, cooking, sterilization) of canned vegetable products and vegetable dishes with meat (pork, beef) and fish (tuna) spread packed in Al / Fe cans.
